II. Town Hall Reports: [10 mins]

- A. CNMS Townhall:
 - 1. Had a turnout of 7-8 people. This is similar to past years.
- B. Non-academic Townhall:
 - 1. Had a turnout of 36 people.
 - 2. Discussed and spread awareness about the GSA and the structure of GSA.
 - 3. Gave an overview about the University Steering committee updates and sport and athletic meetup updates.
- C. COEIT Townhall:
 - 1. Central theme revolved around career opportunities, internships and jobs post grad school.
 - 2. Reps from Career Center joined in to spread awareness about the job market and the world outside UMBC.

III. Special Agenda Items [10 mins]

- A. Motion of no confidence.
 - 1. Motion of no-confidence against the GSA Vice President, was proposed and seconded and was set. Discussion began.
 - 2. The motion needs 2/3rd majority to remove the Vice President from office.
 - 3. If the vote and motion passes, then the Senate will have to elect a new VP from the Grad School's general public.
 - 4. Members of the Senate have raised concerns about the email messages and the language of the emails - issues with pressure on certain committees, power dynamics and keeping boundaries with the members and committees.

- Women of the Senate voiced that they felt discomfort when interacting with the VP, whether due to work pressure or due to deadlines or at feedback follow ups.
- An issue was brought up that E-Council and Senators must communicate via the gsa email and gsa channels like Discord. Any conversations about work done via personal channels could be counted as work-life balance harassment.
- 7. It was discussed and agreed upon that abstain votes will not be counted towards the total number of votes.
- 8. Motion to vote was seconded and ws set, and passed.
- 9. Voting was done by closed ballot.
- 10. Vote of no-confidence passed with 2/3rd majority 7 yes, 5 abstains, 1 no (7 is 2/3rd of 8, not counting the abstaining votes) As a consequence, Shahin Hossain was removed from Office of the VP of the GSA.
- 11. Joel shall create a nomination form for electing a new VP for the GSA.
- 12. After the vote, Shahin Hossain passed a remark that was aimed at Kara. It was something like 'Congratulations Kara, You have finally won after 2 years.'
- 13. After the meeting concluded, it was revealed that many people privately told the E-Council members that they were fearful and were very uncomfortable to talk about the issues regarding Shahin in front of Shahin himself.
